Removing, disabling or blocking Cookies on Your browser might have an effect on your user experience and certain aspects and/or features of the Services and/or Application may be unavailable to You. By using the Services and visiting the Website, You accept iCreate's use of Cookies, including without limitation, third party Cookies that we may choose for any purpose. You agree that you are responsible for adhering to all applicable laws and regulations requiring that Cookie use must be

disclosed, and that we disclaim all liability thereof. We use Cookies and other technologies and tools for marketing or targeting purposes.
